This A17.1a 2005 Code update has been approved by the Florida DBPR, Bureau of Elevator Safety, NAESA, and the EIWPF for the required 8 hours continuing education of NAESA / EIWPF QEI and/or Florida CC holders. The course is a comprehensive review of the changes from A17.1-2000 to the A17.1a-2005 Code course including the ASME A17.1-2005 Supplement adopted by the Florida Building Code effective December 8, 2006. This course also includes review of the changes required to the A18.1-2003 Code also adopted by the Florida Building Code effective December 8, 2006.
